We, the undersigned, hereby make application to Webster County for permission to apply Liquidow™ Calcium Chloride in the described location.

The Applicant agrees to the following:

- To maintain flags identifying the outer limits of the area to be treated for dust suppression. **Flags must be in place by May 3rd and kept visible until October 1st.** Using flags will serve to visually remind the blade operator as to the location of the treated area. Failure to identify the treated area may result in your dust suppression being bladed through. Neither the county nor Jerico Services assumes any liability if your flags are not in place. **If your flags are not in place when we come to apply your dust suppression, we will center the application on your home.**
- If in the County's opinion, sufficient surface deterioration has developed as to become a liability to the traveling public, or if at any time the road conditions become such that the County determines maintenance is required, the County will perform the necessary maintenance. The County at no time will be responsible for the cost of retreatment. The county will blade all spots in preparation for the second application regardless of when the first application was completed.
- Your road will be thoroughly bladed after October 1st in preparation for winter.**
- This agreement is limited to **two** treatments only.
- Jerico Services does not guarantee the performance of the product due to factors such as weather, surface preparation or heavy traffic patterns.
